Note: When you list the pages of the chapter or essay in parentheses after the book title, use "pp." before the numbers: (pp. 1-21).

(Year of publication). Title of chapter. In Editor(s) - initial(s) and family name - of book (Ed. OR Eds.), Title of book - italicised (pp. Page numbers). Place of publication: Publisher. In-text reference: Use the chapter authors, NOT the editors of the book. Treat multiple authors in same format as books (Baker & Lightfoot, 1993) Reference list

### Book chapter - APA 6th referencing style - Library Guides ...

- If the editors of a work are also the authors of all of the included chapters, then it should be cited as a whole book using the examples given for Books.
- Only the first letter of the first word of the title of the chapter or part is capitalised.

### Book Chapters - APA - Referencing Guide - Help and Support ...

To cite a book chapter in APA with an in-text citation, write the author's name to introduce the quote, such as "According to J. O'Neill..." Then, put the publication year and the page number in parentheses at the end of the sentence.

Basic book citation format. The APA in-text citation for a book includes the author's last name, the year, and (if relevant) a page number.. In the reference list, start with the author's last name and initials, followed by the year. The book title is written in sentence case (only capitalize the first word and any proper nouns). Include any other contributors (e.g. editors and translators ...

### **How to Cite a Book in APA Style | Format & Examples**

To create a reference for a chapter in an authored book, just create a reference for the entire book. Follow the authored print book example as a guide for creating the reference in the reference list. Do not include any chapter information within the reference.

If each chapter is written by the same author, just cite the entire book. Parts of the APA Citation Explanation Author's Last name, First initial. Middle initial. Example: Hager, R. J.

Reference Listing for Book Chapter. However, say the author you are referencing has only written a single chapter in an anthology. In this case, you would reference both the chapter and the book. While APA requires italics for the title of a book, the title of a chapter in a book goes in regular type.
